The reverse side of the replacement replica will show the date of the operator's original initial certification under 13:51-1.6(a) and if applicable, N.J.A.C. 13:51-1.6(b), and the date of the operator's most recent recertification under N.J.A.C. 13:51-1.6, or reinstatement and recertification under N.J.A.C. 13:51-1.6(d)."


